The implications of this research have not yet been formulated clearly, and there are still many research data found in the analysis section that have not been analyzed carefully using the theories found in the literature review. In the results section, this research is related to the social reproduction of the dowry for man mentioned about this practice is seen historically very much in conflict with the explanations or data presented seems to be forced. It would be better if the author can strengthen the form of reproduction by showing the results of interviews

It has not yet been clearly seen the implications in the future related to Islamic law and family law, so researchers need to strengthen by adding the relationship and the connections to the law.
